REXBURG SUBSTATION TRANSFORMER

CEO Case stated the Rexburg substation transformer replacement is moving forward to prepare for future growth in that area which serves Hibbard, Roberts, Plano, West Rexburg, Cottonwood, Thornton, and Texas slough. FR had a unique opportunity to purchase this transformer from another utility who had a change of plans leaving them with a brand-new transformer. FR was able to obtain this transformer at a cost that is significantly below its current value, thank you to the board.

HYDRO FACILITIES UPDATE

Island Park, Chester, and Buffalo generated a total of 3,492,242 kWh in May. This amounts to 12.1% of all the kWh billed by PNGC in May and 13.8% of all kWh sold and used by Fall River in May.

Felt Hydro produced 3,572,530kWh in May. When this is included with Island Park, Chester, and Buffalo it amounts to 24.5% of all the kWh billed by PNGC in May and 27.8% of all kWh sold and used by Fall River in May.

BUFFALO

Buffalo hydro produced 165,084 kWh during the month of May.

FELT

Felt hydro produced 3,572,530 kWh during the month of May.
