\$1.5M Instant Owner Rebate Paid To All 2023 **Members** 

For just the fifth time in Co-op history, the Fall River Electric board has authorized an Instant Owner Rebate to be issued to owner-members of the Cooperative that received power in 2023. This year's rebate totals \$1.5 million and marks the fourth consecutive year members have received a rebate!

A number of factors made this rebate possible, including growth of new electric services that totaled 720 new connections, increased kilowatt hour revenue due to a colder winter in 2022 and 2023, and the strong financial condition of the Co-op with a current equity ratio in excess of 48 percent.

Most significantly, the rebate is due to the exceptional financial performance of Fall River's owned subsidiary, Fall River Propane, which increased gallons sold by 11 percent above the previous year. This was in addition to a 24 per-

Rebate credits, which are calculated based on the amount of power you used in 2023, will be applied to owner-member statements in February, so check your statement for your rebate.

## Members To Elect Board Candidates In 2024

One of the seven guiding principles of Fall River Electric Cooperative is democratic member control, wherein our Co-op is controlled by its owner-members who actively participate in setting policies and making decisions. The elected representatives of Fall River's Board of Directors are accountable to the membership and this year, three of those nine seats are set for election. The seats up for election this year are District 1, the Rexburg/Rigby areas represented by Husk Crowther; District 5, West Driggs/Tetonia where Brent Robson currently serves; and District 6, the Ashton area represented by Dede

The nominating committee will select candidates for each of these three districts and a notice as to the eligible candidates for each district will be posted at the Ashton Idaho office of Fall River Electric on April 19. Members interested in being on the ballot can file a Nomination by Petition by the deadline of April 12, 2024.

## Food Drives Result In Near Record **Donations**

During the holiday season, Fall River Electric's staff conducted four food drives at area grocery stores in support of our local food banks and pantries. It was the Co-op's fifth year of supporting families in need.

New this year was a competition between several local high school senior classes. Each class was invited to hold their own food drive prior to the Christmas holiday break. The class collecting the largest number of pounds per senior class member was awarded a \$1,000 prize, along with a traveling trophy.

North Fremont High School's senior class collected 26.98 pounds per 43 senior students to earn the top prize. North Fremont was followed by West Yellowstone with

10.71 pounds per 21 students, followed by South Fremont with 9.80 pounds per 98 students, and Teton with 2.26 pounds per 137 students.

A total of just over 5,000 pounds of food was collected for the regional food banks, including Teton Valley Food Pantry in Driggs, North Fremont Food Pantry in Ashton, West Yellowstone Food Bank, and to the food pantry in Rexburg operated by Eastern Idaho Community Action Partnership. This was nearly double what was collected last year!

In addition to the non-perishable food donated, the food pantries received \$2,327 in cash donations from individuals and by Fall River Flectric.

## Fall River Electric Earns Idaho Private 100 Spot Again

For the fourth year in a row, Fall River Electric Cooperative has been named as part of the Top 100 privately-owned companies headquartered in Idaho.

The recent recognition came about as part of Nerus Strategies' annual survey of top performing privately held Idaho-based companies, as compiled by the international accounting firm KPMG.

Celebrating Idaho's top companies

Fall River Electric was ranked #78, up five spots from last year. It is the only electric utility listed in the Top 100.

"Our continued focus on exceptional customer service to our owner-members is a key contributing factor to our growth," says Bryan Case, Fall River Electric's CEO/General Manager. "Our Cooperative has seen remarkable growth in our equity due in part to our board's focus and our staff's excellent work in controlling costs."

Fall River Electric was one of only twelve privately-owned companies based in east Idaho that made the list this year.

### Parties File Objections To Dam **Removal Agreement** Article courtesy of NewsData



The states of Idaho and Montana, along with the Public Power Council (PPC) and the Inland Ports & Navigation Group, have each filed objections to the proposed agreement to temporarily settle litigation over the Columbia River Systems Operations (CRSO) that is intended to be a precursor to lower Snake River dam removal.

The parties claim the proposed deal would harm their interests and have asked the U.S. District Court for the District of Oregon to deny the stay to litigation. The State of Idaho argues that a stay would "effectively lock Idaho out of court" in relation to its counterclaim, contending any decision to breach the four lower Snake River dams (LSRD) must be authorized by

The State of Montana agrees with Idaho, further stating they were excluded from the settlement negotiations and that the pending agreement will impact electric cooperatives in their state.

PPC contends the U.S. government's commitments in the pending agreement go beyond BPA's lawful authority under the Northwest Power Act.

Finally, the Inland Ports argue that the stay's ten-year plan of operations "poses serious threats to safe navigation" through the eight locks on the river system.

Plaintiffs, defendants, and the Six Sovereigns that filed for a stay to the case through 2028 say the parties unhappy with a proposed short-term settlement failed to show how they would be harmed if litigation is paused for up to ten years.

## **Board Member Jeff Keay Receives MECA Award**

Jeff Keay, a board member at Fall River Rural Electric Cooperative, was the recipient of the Montana Electric Cooperatives' Association Hard Ridin' Award.

In September 2021, Jeff was diagnosed with Adenoid Cystic Carcinoma, a rare salivary gland cancer, after his 41-year-old son was diagnosed with Stage 4 colon cancer and subsequently encouraged Jeff and his siblings to be screened for cancer.

Jeff had noticed a slight change in his voice and was also experiencing some trouble swallowing. Doctors discovered the tumor in August 2021. Jeff endured three surgeries to remove the tumor. Chemotherapy did not work, and he decided to forgo radiation, but has now been cancer free for over a year and a half.

After receiving his cancer diagnosis, Jeff was determined to be positive and to take positive actions. Everyday Jeff expresses gratitude for something in his life, and in the life of his family, and whenever he



comes in contact with other people, he seeks a way to say something nice, encouraging, or uplifting to them.

Jeff also says he is actively working to shorten his "bucket list." He's taken a backpacking trip with two of his adult sons, and he and his wife Judy took a trip back to his home states of Wisconsin and Michigan to visit friends and take in last fall's colors.
