Preconditions:

- The building is electrically heated.
- The existing insulation value is between R-0 and R-5 value and noted by contractor.

Post-conditions:

- Installation of insulation in wall or attic/roof spaces per the level shown in the payment table.
- Insulation of insulation in floor or crawl spaces is not eligible.
- Contractor invoice showing order/purchase date and installed cost must be submitted with this form.
