## YOUTH TOUR CONTEST RULES

1. The student must be a sophomore or junior in high school – Spring Semester 2025.
2. The student and or parent or guardian must be served by Fall River Rural Electric Cooperative and the account number must be listed on the application.
3. The student must write an essay on the subject: **“You are in charge of the energy efficiency program at your school. Describe ways you would recommend for your school to use electricity more efficiently.”** The essay should be at least one, and no longer than two, double-spaced typed pages. Please do not use AI to write your essay. Statements may be run through an AI checker.
4. Submit the application and attached essay to Fall River Rural Electric Cooperative by close of business, Friday, April 18, 2025.
5. Make sure your name, address, telephone number and that the Fall River Rural Electric Cooperative member number appears on the essay.
6. Applicants may be requested to appear at a Fall River area office for an interview during the selection process to be scheduled during the month of May.
7. Students must be available to attend the 2024 Youth Rally held in Nampa, ID. July 7-11, 2025.
